UnChong Parry, Kings County Behavioral Health, presented on the findings from the 2020 Kings County Data Notebook and gave an update from the committee on the 2021 Data Notebook with a final report coming to this board at the January meeting.

Staff Report

Dr. Lisa Lewis, Kings County Behavioral Health Director, noted the following:

- Welcomed new employee, Tony Afonso who is joining Behavioral Health's fiscal team;
- The department is applying for additional grant funding from the Mental Health Student Services Act (MHSSA), which will fund services on school campuses;
- There is a community survey currently on the Behavioral Health website in English and Spanish.

Advisory Board Member Comments

Ken noted that he participates on the Kings Partnership Mental Health work group and encouraged everyone to join the meeting and listen in to what is happening in our communities; he noted that the DRAW program needs additional help and support; he encouraged everyone to watch the HULU show, "Dope Sick"; he wondered if CA is a participant in a settlement he heard about and Diane Freeman (Kings County Counsel) said there was a proposed settlement agreement going to the Board of Supervisors to see if we will participate in the settlement; there is good participation in the Family Support Group; and the new ACT services seem to be helping their families immensely.
